Kaur had only recently received her permanent resident card. According to her Facebook page she was from Kapurthala in Punjab, India.



Common Questions About ATIP Assignment

What is the difference between a **formal** and **informal** request?

- Formal requests are requests that you have to write an inquiry for – you ask for information that you want to receive from the level of government/organization
 - You have to pay a \$5 fee for each formal request you file
- Informal requests are requests that have already been released. You do not need to pay to get them because they are already compiled. You just need to fill out a form to get them released to you.

What's the deal with briefing notes and filing a federal ATI request?

- You may recall a few lectures ago how David walked us through the briefing note portal
 - The briefing note portal is also a federal government portal
- When filing your federal information request, a suggestion was given that to make it easy, you can just file a federal request asking for the release of a few briefing notes whose reference numbers you'd get from the briefing note portal
- If you want to file a federal request on something else, you are more than welcome to

How Do I Word My Request?

Be concise, be as specific as you can

Include a reasonable timeframe

Include your contact information

Include a note on cabinet confidences

What Do I Submit?

- 1. Open a word document
- 2. Let's say you file a federal request first. Copy and paste the wording of your request into your word doc
- 3. Once your request is filed, include a screenshot of the confirmation email that shows the request was received
- 4. Repeat for Provincial and Municipal Levels

For your 5 informal requests

1. In the same word doc, provide a screenshot of your confirmation

A Few More Points

- When filing your municipal request, make sure you know where to file it; not every municipal organization can be found on the municipal request portal
 - For example: Toronto District School Board (TDSB), Universities, Toronto Hydro, Toronto Police, Toronto Public Library all have their own portals for filing access to information requests
- Need links for the ATIP portals? Check Syllabus or check ATIP Channel on Slack!
- This assignment just asks you to file the requests, not get them back and show us what was released to you.
 - Remember that government organizations have 30 days to compile your request, but usually this will be extended, so it is not expected that you will get anything back by the deadline
 - You may, however, get back an informal request depending on the department. I just filed one last night and got it released literally 2 hours later!
