- 2) When major equipment upgrades or purchases are required, how does funding allocation change to accommodate those purchases?
- 3) How have conversations with Chief Peter Beatty progressed since the fires?
- 4) How does the Capital Asset Inventory System work?
- 5) Is there any kind of system that monitors on-reserve fire fighters across the country?
- 6) How is training for fire fighting managed in Saskatchewan?
