Dear Ruth Tecle,

Thank you for your inquiry to the Canadian Human Rights Commission.

The Commission takes complaints of discrimination in federally regulated areas based on specific grounds of discrimination. The prohibited grounds of discrimination are: race, national or ethnic origin, colour, religion, age, sex (which includes pregnancy), sexual orientation, marital status, family status, disability, a conviction for which you have been granted a pardon. The Act also protects against harassment when this behaviour is related to one of the above mentioned grounds.

We do not generally take complaints related to professional hair or professional appearance. In some cases where the human rights complaint about hair or appearance is linked to a religious need, we would consider this as being linked to the ground of religion.
